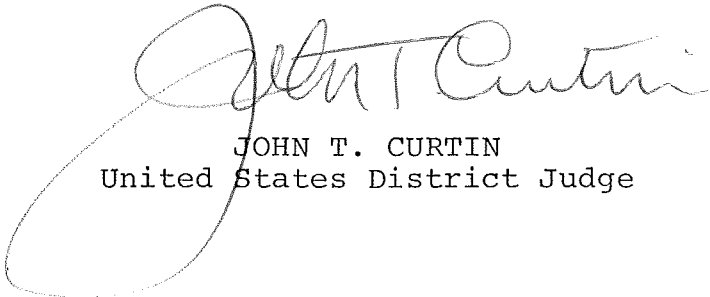
Dear Ms. Vigod:
