- MAILING OF INFORMATION LETTER AND RESPONSE FORM: waiting on completion of mail list in order to mail this letter and response form out to all that might be interested in being either a participant, resource person, or facilitator of the upcoming public participation project activities. Peter Mallett has agreed to work with Warren Flint in modifying the letter originally composed by Barry Boyer so that we can solicit all the information that we need (e.g., identity of teleconference facilitators) in as short a timeframe as possible. The following timeline has been established for information mailing and follow-up.
 - * Initial information letter sent out by <u>March 31</u>, <u>1990</u> that contains the following information:
 - scope of the entire project with appropriate background information concerning already completed phases
 - specific request for participants in the fall workshop
 - additional request for persons to become involved in facilitating the teleconference event in each of the local downlink sites
 - enclose a response form with the letter that will include answers to the above requests as well as seeking information about the person's background and interests related to the topic of toxic chemicals and human health risks
 - * Response forms due back to the Great Lakes Program by April 20, 1990.
 - * Follow-up communication to each positive responder by May 10, 1990 with more specific information on the activities that they indicated they would be interested in being involved with.
 - * Select September workshop participants by <u>June</u> <u>15</u>, <u>1990</u> and notify. These workshop participants would include those persons identified as potential local site <u>facilitators of the teleconference</u> event.

<u>Date</u>: Friday evening, September 14 to Sunday noon, September 16, 1990
<u>Location</u>: Downtown Buffalo (Hilton or Hyatt Hotels): alternative location - the Red Jacket Inn on the Niagara River, Niagara Falls

Purpose: - Create a public policy agenda for the upcoming teleconference

- Provide additional material & background for the videotape productions

- Allow for briefing of the facilitators for the teleconference event

- Provide the opportunity for <u>Teacher Group</u> that will begin curriculum development activities on risk to develop plans and strategy for achieving their tasks

Participant Number: 60 to 80 persons with no more than 10 per task group

Workshop Agenda: Friday Evening

- POINT COUNTER POINT PRESENTATIONS ON THE ISSUE OF RISK AND THE CONCEPT OF RISK ASSESSMENT (possibly have this activity as a dinner presentation). Members of each BREAKOUT SESSION GROUP would sit together at dinner to get acquainted.
- After-dinner BREAKOUT SESSIONS would be designed to mix members of each <u>Specialty Task Group</u> up with a facilitator. These groups would meet for the remainder of the evening to address the following issues:

Characterizing the problem

- * severity
- * scope
- * immediacy for solutions

Managing risks

- * menu of strategy alternatives
- * reaction to and ranking of alternatives

Saturday Daytime --

-Break participants out into <u>Specialty Task</u> <u>Groups</u> according to the following design:

- * industry representatives
- * environmental special interest groups
- * legislators
- * public health & social service officials Ask these groups to focus their discussions on the ultimate product of creating recommendations on a policy agenda for their group.

STATUS OF PUBLIC BRIEFING/STUDY BOOK:

* Warren Flint has already compiled much of the summary information from previous program phases (<u>e.g.</u>, Disciplinary Briefing Book and International Working Conference Task Group Reports) into a single document for further editing and refinement.

- * We will seek DEC involvement for non-technical editing of document produced by Warren Flint with help from Peter Mallett, after review by the Public Participation Committee.
- * At the end of each chapter of the Public Participation Briefing/Study Book there will be a listing of several questions that will guide the discussion of the <u>Specialty Task Groups</u> during the September Workshop and the local community meetings during the Teleconference broadcast.

STATUS ON FUNDING FOR THE PUBLIC PARTICIPATION PROJECT:

- * No funds from the Mott Foundation
- * Proposal out to the Gund Foundation
- * Canada Department of National Health & Welfare (has indicated a commitment of approximately \$85,000 toward total project)
- * Proposal out to the Michigan Protection Fund
