Dear Great Lakes Activist:

Citizens' organizations in the Great Lakes Basin have made great strides in addressing issues of critical importance through cooperation, collaboration and coordination of activities. To extend this tradition, Great Lakes United will convene a two-day retreat of basin citizen group leaders on April 5 and 6, 1990 at the Merriman Executive Inn, 7600 Merriman Road near the Detroit Metropolitan Airport (313) 728-2430. The retreat will provide an opportunity for citizen group leaders to discuss our individual activities and to plan cooperative efforts.

Two years ago, a similar working meeting was convened by the Lake Michigan Federation. This meeting proved highly successful in improving the working relationship between Great Lakes citizens groups. We hope to build on this success and to give all of us a better understanding of each other's activities and to identify new opportunities to undertake collaborative projects or programs.

We sincerely hope that you or another representative of your organization will be able to attend.

Because of the limited space available at the meeting, we are restricting the attendance to one representative per group.

We ask that you return to us as soon as possible the enclosed form for confirmation of your attendance.

We are asking each of you to make your own travel arrangements. We also request that you provide us with suggestions on gaps in the activities of existing citizens groups and opportunities for collaborative action. Possible topic headings for discussion of action include: the Great Lakes Water Quality Agreement, Remedial Action Plans, Lakewide Management Plans, Human Health, Air Toxics, Wetlands and Land Use, and Jobs and the Environment.
