RE: 1991 elections

Enclosed is a list of GLU officers and directors whose terms expire as of the May 3-5, 1991 annual meeting in Ottawa. Positions to be filled include:

- all six officers, with all incumbents eligible for re-election except the first vice president. (Under by-laws restrictions, this position must be filled by a U.S. member this time because the current president is Canadian).
- three regional directors, representing Region II/Lake Huron, Region IV/Lake Erie, and Region VI/St. Lawrence. Incumbents in all three positions are eligible for re-election.
- five directors-at-large, 3 of whom must be from the U.S. and 2 from Canada. All incumbents are eligible for re-election except one U. S. position.

#### Call for Nominations

All organizational members of Great Lakes United are invited to submit nominations for any of the positions listed. If you wish to submit a nomination, please ascertain first if the potential candidate is able and willing to serve the organization. Please target nominations for a specific office or position and include the candidate's address and phone numbers, both work and home phones if possible.

The nominating committee is looking for candidates who believe in the principles of Great Lakes United and who will be active and dedicated to carrying out its work. This will, of course, include commitment to attending virtually all board meetings and serving on committees as requested.

All nominees must be members in good standing of a GLU member organization.

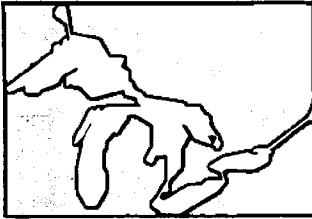

To make this schedule workable, we ask that you submit names to the committee by March 4, if possible so the committee will have time to review them.
