Dear Mr. Iler:

This letter is a followup to our conversation about achieving charitable status for Great Lakes United. As we discussed, it appears to be best to submit a new application as a newly incorporated organization.

Enclosed you will find the information you requested to initiate this application. Included with this letter is:


In this pile you will find:

Statement of Activities

Great Lakes United is a research and educational organization dedicated to providing information and technical assistance to citizens on environmental issues and problems in the Great Lakes Basin. Great Lakes United undertakes to make available information and assistance to citizens using a variety of methods. The organization:

- a) Conducts research on environmental problems in the basin;
- b) Makes available the expertise of staff and volunteers to help citizens find information;
- c) Provides the service of a technical analyst to give advice on pollution and other environmental problems;
- d) Compiles a resource centre and clearinghouse on environmental problems in the Basin;
- e) Writes reports on particular environmental issues;
- f) Publishes a regular newsletter The Great Lakes United, which provides information on current Great Lakes issues;
- g) Publishes a quarterly magazine The Bulletin of Pollution Prevention which contains information on pollution prevention activities; and
- h) Sets up educational workshops and presentations on Great Lakes environmental problems for citizens throughout the Basin.
- i) Provides forums for individuals and organizations to participate in issues regarding the natural resources of the Great Lakes, their connecting channels and the St. Lawrence River, including but not restricted to fish and wildlife management and habitat protection, water quality, regulation of water levels and flows.
