





# Great Lakes United at a glance

Great Lakes United is a not-for-profit coalition of community-based and regional organizations and individuals, from the United States, Canada, and First Nations. Our mission is to work together to develop and maintain a healthy ecosystem in the Great Lakes-St. Lawrence River Basin.

GLU emerged in 1982 when environmental, conservation, labor and community organizations saw the need to create a diverse, regional coalition to organize, educate and advocate for the protection of the Basin as an ecosystem. Members such as the Assembly of First Nations, Erie County Water Authority, Greenpeace Canada, Michigan United Conservation Clubs, Société pour Vaincre la Pollution, Stratégies Saint-Laurent, and United Auto Workers, exemplify the diversity of this unique coalition. GLU fulfills its charge from its members by:

- Promoting and coordinating citizen action
- Building strong grassroots leadership
- Educating citizens and policy-makers
- Developing and advocating for effective policy initiatives

Great Lakes United's policies are guided by resolutions debated and adopted by member organizations at our annual general meeting. Through this process, GLU acts as a crucible for working out sound, practical Great Lakes policies that balance diverse stakeholder interests.

GLU is governed by a 23-member Board of Directors composed of six regional representatives, one Native Nation representative, five U.S. at-large representatives, five Canadian at-large representatives, and a six-member executive committee. They represent regions across the Great Lakes-St. Lawrence River basin, from Duluth, Minnesota, to Chicoutimi, Québec. The Board meets four times each year. In addition to regular standing committees (finance, bylaws, personnel, and executive), board members participate in five task forces: Clean Production, Biodiversity and Habitat Protection, Healthy Communities, Sustainable Waters and Nuclear-Free Great Lakes.

Great Lakes United's staff is composed of an executive director, an accountant, a communications coordinator, two field coordinators, a devel

opment assistant, a part-time office assistant, and volunteers and interns. We also contract for short-term field coordinating services with regionally based member groups. Our offices are in Buffalo and Montréal.

Great Lakes United's vision is of a Great Lakes-St. Lawrence River ecosystem that is a healthy home for all living creatures. It is a home blessed by a broad variety of natural habitats, and with a wide diversity of creatures and peoples. As humans we depend on and are part of the natural world. We bear a responsibility to protect the survival of Great Lakes flora and fauna for future generations.

GLU implements this vision according to seven guiding principles:

- Protection, prevention and restoration should be the basis for environmental programs and actions
- All environmental programs and actions should embody an ecosystem approach
- There are no safe limits for persistent toxic substances and therefore their production, use and disposal should be eliminated
- People have a responsibility to act in ways that protect the well-being of the other living creatures with whom we share this home
- Environmental programs should take into account the wider social and economic contexts and strive for social equity for all people
- 5 Impacts on jobs and economic opportunities should be part of the consideration in developing environmental programs, with a particular focus on helping dislocated workers
- Action by grassroots, community-based organizations is an essential driving force behind achievement of our goals.

# L'Union des Grands Lacs et du St-Laurent: Un bref survol

L'Union Saint-Laurent, Grands Lacs (USGL) est une coalition sans but lucratif d'organismes communautaires ou régionaux et d'individus, des États Unis, du Canada et des Premières Nations. Notre mission est de travailler ensemble au développement et au maintien d'un écosystème

# Grands Lacs Saint Laurent en santé.

L'USGL a été fondée en 1982 lorsque les organismes environnementaux et de conservation, les groupes communautaires et les syndicats ont senti le besoin de créer une coalition diversifiée chargée d'organiser, d'éduquer et de plaider en faveur de la protection du bassin comme écosystème. Des membres tel que l'Assemblée des Premières Nations, Erie County Water Authority, Greenpeace Canada, Michigan United Conservation Clubs, La Société pour Vaincre la Pollution, Stratégie Saint-Laurent et le syndicat des travailleurs de l'automobile démontre la diversité du membership de cette coalition sans pareil. L'USGL remplit les mandats donnés par ses membres:

- Promouvoir et coordonner l'action des citoyens
- 6 Construire un leadership à la base forte et solide
- Eduquer et sensibiliser les citoyens et les décideurs politiques
- 6 Développer et plaider en faveur d'initiatives politiques efficaces

L'USGL a pour politique interne de se laisser guider par des résolutions débattues et adoptées par les organismes membres lors de son Assemblée Générale Annuelle. Grâce à ce processus, l'USGL agit comme un creuset pour l'élaboration de politiques pragmatiques et équilibrées pour les Grands Lacs et ce, avec l'aide d'intérêts multipartites.

L'USGL est dirigée par 23 administrateurs qui se composent de 6 représentants régionaux, une représentante des Premières Nations, 5 représentants des États-Unis, 5 représentants Canadiens et six membres du comité exécutif. Il représente des régions d'un bout à l'autre du bassin des Grands Lacs Saint-Laurent, de Duluth Minnesota à Chicoutimi Québec. Le conseil d'administration se réunit 5 fois par an. En plus de participer à différents comités (finances, personnel exécutif etc...), les administrateurs participent dans cinq groupes de travail: Le groupe de travail Production Propre, Biodiversité et Protection des Habitats, Les Communautés en Santé, L'Eau Ressource Viable, et les Grands Lacs Libres du Nucléaire.

Les employés de l'USGL se composent d'une directrice exécutive, d'une comptable, d'un coordonnateur des communications, de deux coordonnateurs de dossier, d'une assistante au développement, et d'une employée de bureau à mi-temps et des bénévoles. Nous offrons également des contrats de courte durée à des partenaires tout autour des Grands Lacs et du fleuve.

La vision de l'Union Saint-Laurent Grands Lacs pour cet écosystème est celle d'une communauté en santé pour toutes formes de vie. C'est un endroit merveilleux ou l'on retrouve une grande variété d'habitats naturels, d'espèces vivantes et de personnes. Comme être humain, nous sommes intimement dépendants du monde naturel. Nous avons la responsabilité de protéger la survie de la faune et de la flore des Grands Lacs et du Saint-Laurent.

L'USGL applique cette vision à travers sept grands principes:

- 5 La protection, la prévention et la restoration doivent être la base des programmes et des actions en environnement.
- Toute action ou programme en environnement devrait être basée sur une approche écosystémique.
- 5 Il n'existe aucune norme sécuritaire en ce qui à trait aux substances toxiques persistantes et conséquemment leur production et leur utilisation devraient être abolies.
- La population a la responsabilité d'agir en faveur de la protection du bien être des autres formes de vie avec qui elle partage ces lieux.
- Les programmes environnementaux doivent tenir compte du contexte social et économique global et viser l'équité pour tout le monde.
- Les impacts sur les emplois et les opportunités économiques doivent être pris en considération dans le développement des programmes environnementaux avec une attention particulière sur l'aide aux travailleurs qui sont touchés.
- Les actions des groupes de bases et des organismes communautaires sont les vecteurs essentiels qui nous permettrons d'atteindre nos buts.

# President's message

Now that I've completed my first year as president of Great Lakes United I have the opportunity to report to you about how things are going. The experience has been great. We have a truly remarkable organization that we probably underappreciate. There are hundreds of major ecosystems in the world: think of the Everglades, Hudson Bay, the Amazon, Kalihari, the Andes, the Mediterranean each threatened in one way or another. Each has people who care deeply about their part in it as a home, or as an example of the ways in which life uniquely flourishes in a particular place as nowhere else, or as a source of food and sustenance, or just because caring about a place really does come naturally to people.

In most of these places people have been able to organize to try to protect their particular interests, but rarely have people been able to come together across diverse interests and say, "We have a common interest and it crosses international boundaries and cultures, it's broader than my interest in good fishing or a place to sail or whatever particularly draws me and keeps me in this place." Rarely has the general good, the responsibility to appreciate, protect and restore a major, globally significant ecosystem been given a consistent and powerful voice whenever and wherever decisions are being made that affect that ecosystem.

Although we in the Great Lakes and at Great Lakes United have not yet achieved that level of influence and effectiveness, we have been able to build a solid working coalition of organizations and people that can be a model for the rest of the world.

From where I sit here are just some of the things that are going well:

- Margaret Wooster, our executive director of almost two years now, has established herself as a capable and inspiring leader of our organization. The staff is working exceptionally well together: work is getting done skillfully and on time, the membership is being activated, and we are earning a reputation for skill and effectiveness.
- Our 23-member board of directors is a great bunch of people who are working hard and effectively in their own communities and in their organizations on just about every issue facing the Lakes. Board members

seem to like each other. Our meetings are fun and full of exciting discussions which sometimes actually end in decisions and actions. Margaret has done a great job of utilizing the many skills of the board and GLU's impact on the larger Great Lakes community is clearly the responsibility of many more individuals than just the staff and officers—as it should and must be.

We have done a good job setting priorities and being clear about our mission and focus. This is a difficult task for environmental organizations since, after all, the "environment" consists of everything. In this time of new and pressing threats while our governments are withdrawing from their past environmental commitments, every day brings more demands on our staff and resources. We have been clear that GLU's role is to be a collective voice on those issues which are by their character basinwide and which require decisions and actions at the multinational level. We need to support our local members in their local efforts, but not take a leading role at that level.

Therefore we have chosen to focus first on protecting the Great Lakes Water Quality Agreement and insisting that it be fully implemented: "Finish the job." For this purpose we have organized a series of water quality hearings throughout the region. We are also planning to hold Great Lakes days in Washington and Ottawa to reinforce to our national politicians the fact that the job is not complete.

We have also chosen to work on the U.S.-Canada Binational Toxics Strategy to make certain that it yields real reductions in toxic pollution while not backing away from the commitment to reduce the discharge of these poisons to zero and eliminate them from our environment.

We have focused attention on the binational Great Lakes-oriented treaty organization, the International Joint Commission, and the semi-formal organization of Canada-U.S. environmental leaders, the Binational Executive Committee, because without effective binational governance capacity, Great Lakes protection and restoration will certainly flounder.

We have given priority to building alliances with the Native and First Nations of the Great Lakes bioregion who have had their fundamental rights to live in a healthy natural environment violated and whose claim to enforce those rights now makes powerful demands at all levels of government to make amends and protect and restore the Great Lakes now and for future generations.

We have identified continuing systematic and regionwide threats to the indigenous animals and plants of our region and built a regionwide biodiversity protection strategy.

Likewise we recognize the threat to the Great Lakes from irresponsible water use, diversions, climate change and the commercialization of water resources.

- We now have a strong presence in the province of Québec, where people have too long suffered, as Daniel Green likes to say, from contamination without representation. The institutions of Great Lakes governance mark the border with Québec (technically, the spot where the St. Lawrence River ceases to be a Canada-U.S. border and heads northeast) as the place where their obligations end. But the poisoned waters continue to flow. Where the waters join the ocean the beluga whales continue to endure the tragic consequences of massive environmental poisoning. Stéphane Gingras has done a great job building our office in Montréal. Our board members in Québec—Liliane Cotnoir, Daniel Green and Marc Hudon—have been a powerful presence for GLU throughout the province.
- We have begun to make a small contribution to efforts to build a strong world environmental movement that can act effectively at the level of global decision making. Since our organization was created sixteen years ago, the pace of globalization has accelerated. In fact, a significant portion of the reported reductions in Great Lakes pollution has resulted from the closing of hundreds of polluting factories which, in pursuit of low wages and unwilling to redesign for pollution prevention, chose to take their polluting ways to more tolerant countries. There the ravaging of the environment continues and much of the resultant pollution makes its way back here in the air currents and agricultural trade movements. We have a responsibility and opportunity to share our experiences and provide support for emerging environmental leadership in developing countries. We have begun this work by participating in plans for a public forum and local organizing for the first international negotiations on a global treaty to control some of the nastiest pollutants, so-called persistent organic pollutants (POPs), being held in Montréal in June.

Great Lakes United is working hard on a broad front, but, of course, much remains to be done. Here are some challenges GLU faces in the coming period:

- We have not yet figured out how to effectively respond to the situation in Ontario, where government cuts and an aggressively pro-business regime have devastated the environmental protection capacity of the province. Every day brings news of further retreat from Ontario's past commitments. GLU needs to have a stronger, more visible presence in Ontario.
- We need to be politically stronger in dispelling the myths that have been used to justify these retreats from environmental commitments in both Canada and the United States. We are two of the wealthiest countries on earth and too many people have bought into the falsehood that "there isn't enough money anymore" for major new environmental programs. Just look around you in the wealthy parts of our many Great Lakes communities. There's plenty of money. The question is what does it get used for and who has a say in how it is used.
- We need to broaden our constituencies and deepen their level of support. There are millions of people who care about the Great Lakes. They need to hear from us and support us. Far too much of our resources come from foundations. They have supported us because they think we're doing good work. They turn to us to help explain what's going on in the Great Lakes. And their investments have yielded much in return. I think their support should continue and increase, but our memberships and private donations need to increase even more.

I'm enjoying being Great Lakes United's president and I look forward to working with all of you. Let's stay in touch.

The task force continued its support of Great Lakes habitat protection through its weekly publication of the email newsletter *Habitat Watch*, which now reaches over 300 readers; continued to counter anti-conservation legislation through alerts, letter campaigns and community organizing; and supported membership projects including the Tip of the Mitt's Great Lakes Aquatic Habitat Network and Fund, Long Point Bird Observatory's Marsh Monitoring Project, the Federation of Ontario Naturalists' Partnership for Public Lands, Audubon's Conserving Ohio's Rivers and Wetlands, and the River Alliance of Wisconsin's Small Dam Removal project.

# Highlights

- Coordinated the New York State hub of the Great Lakes Aquatic Habitat Network.
- Completed proceedings from the "Fishing for Solutions" conference that brought different and opposing interests in the Great Lakes fishery into dialogue.
- Laid the groundwork (funding, planning committee, conceptual development, materials) for the next conference on fishery issues, focusing on managing for sustainability, to be held in fall, 1998.

# Clean Production Task Force

#### Mission

To develop ecologically sustainable production systems by supporting efforts to sunset persistent toxic chemicals, prevent pollution, and conserve raw materials and energy; and to support environmental and economic justice for communities and workers affected by the transition to clean production.

Task force work this year was primarily tied to specific programs under the Great Lakes Water Quality Agreement, including the International Joint Commission's (IJC's) Public Forum (ninth biennial meeting), the United States-Canada Binational Toxics Strategy, and GLU's own Great Lakes water quality hearings. In addition, Montreal staff completed three years' service as environmental representative in Canada's Strategic Option Process, a multi-stakeholder process to develop regulations on 25 chemicals deemed toxic under the Canadian Environmental Protection Act. The task force publishes a monthly e-mail newsletter, *Toxics Watch*.

# Highlights

Organized public participation and press coverage for the International Joint Commission's November, 1997 Public Forum. Produced maps, media stories and reports — including Treading Water, Our Lakes Our Health Our Future and Environmental Injustice and the Great Lakes Water Quality Agreement — on pollution and human health issues in the Great Lakes.

- Prepared for a series of citizen hearings in communities across the Basin on Great Lakes water quality which will take place June - October, 1998. Preparations have included scheduling, preparation of brochures, factsheets and other materials, and developing contracts with local partners in each community.
- A Recruited environmental expertise to help define next steps for the Binational Toxics Strategy, dedicated to the virtual elimination of persistent toxic substances in the Great Lakes ecosystem.
- Provided logistical support to Physicians for Social Responsibility organizing global ENGO participation in the third international forum on POPs (persistent organic pollutants) in Montreal, June 28-30, 1998.
- 5 Tracked and publicized issues related to toxic regulatory enforcement in the Basin, including permit violations by Quebec's pulp and paper mills and Ontario Hydro.
- Represented GLU at public hearings on Great Lakes/St. Lawrence River clean production issues and in Strategies St. Laurent, an umbrella organization for Quebec's 10 "Zones d'Intervention Prioitaire" or ZIPs.

# Healthy Communities Task Force

# Mission

To enhance communication and action between citizens working on RAPs in order to ensure implementation, and to bring RAP experience and research to a broad array of sustainable community initiatives.

The Healthy Communities Task Force has traditionally worked on cleanup of contaminated sites in the Great Lakes Basin, with particular focus on the 43 Areas of Concern (AOCs) designated by the International Joint Commission in the mid-1980s. However, in 1997 this task force broadened its focus to a watershed framework in order to encourage grassroots stewardship of ecosystems beyond the AOCs. A major initiative for this task force was the planning of GLU's 1998 Annual General Meeting which focused and convened river and watershed-based groups from around the basin on the theme "Rivers to Lakes."

# Highlights

- So Brought the national River Network, Wisconsin Rivers Alliance, New York's Rivers United, and other river groups to share strategies and resources at GLU's sixteenth annual general meeting
- Continued involvement in RAP implementation and evaluation.
- Developed recommendations for federal legislation on contaminated sediment cleanup and standards with the Coast Alliance, Sierra Club and others.
- Developed, with the Assembly of First Nations, a model Community Action Plan for First Nation communities.

# Sustainable Waters Task Force

#### Mission

To develop a comprehensive basin-wide water conservation policy, which will lead to cooperation and co-ordinated actions by all levels of government with jurisdiction over Great Lakes waters

GLU continues to follow up on the Fate of the Lakes report, released by the task force in February, 1996 and to provide information and support to communities around the Basin and across the continent who are facing basic changes to their water supply, including privatization, diversion and/or shortages. The Fate outlines a broad strategy for water conservation at the municipal level that will be part of a series of presentations this year,

including one to the Great Lakes/St. Lawrence River Mayors Conference in Windsor this July.

# Highlights

- 5 Campaigned in eight states for a thorough review of an out-of basin water diversion from the Cuyahoga River to accommodate suburban development outside of Akron, Ohio.
- 5 Joined Midwest Environmental Law and Policy Center in a suit against the US Army Corps of Engineers for its ruling that groundwater diversion is not a diversion requiring review under the U.S. Water Resources Development Act.
- With the Canadian Environmental Law Association, challenged the Ontario Ministry of Environment's right to permit for private sale of Lake Superior water to an Asian country, on the grounds of the precedent for water trade this could set.

# Nuclear-Free Great Lakes Task Force

Mission.

To address nuclear issues in the Great Lakes, to liaise with other task forces, and to explore opportunities for renewable energy development.

Chairs

The task force was created to bring nuclear issues in the Great Lakes Basin to the attention of the International Joint Commission and the two federal governments, and to include radionuclides in policies and strategies, including the Binational Toxics Strategy, dealing with long-lived toxic substances.

# Highlights

- Organized a workshop on Great Lakes nuclear issues at the IJC's November Public Forum.
- § Intervened through letters and hearing testimony in nuclear power plant

relicensing and monitoring; radioactive waste clean-up and on the proposed use of MOX in commercial reactors.

Developed an alternative energy projects with an Argentinean ENGO partner, funded by the Canadian International Development Agency.

# Lake Superior coordination

GLU board president John Jackson continued to serve as co-chair of the Lake Superior Forum, a binational, multi-stakeholder advisory committee to the federal governments on the Binational Zero Discharge Programme.

Great Lakes United acted as fiscal agent for the Lake Superior Alliance Lake Superior Sustainable Basin project, and continues to work with the LSA on Lake Superior issues, including phasing out toxaphene and evaluating impacts of mining on surface and groundwater.

# Communications

GLU's 32-page newsletter was issued quarterly, except for last summer's issue, which was replaced by advertisements and solicitations for citizen involvement in the International Joint Commission's Public Forum. The Biodiversity and Clean Production task forces issued regular updates on Basin developments through our fax and email *Watch* publications

Last fall for the first time GLU employed the services of a national media consultant, Environmental Media Services, to help us secure substantial newspaper and radio coverage in three general areas: the IJC Public Forum, recently developed science about toxics chemicals and human health, and the Great Lakes Water Quality Agreement. The results were excellent, with wide coverage of the issues across the Basin in October and November.

This year Great Lakes United finally developed a Web site—www.glu.org—and is now starting to post information there, including this year's schedules of GLWQA hearings, background and progress reports on the Great Lakes Binational Toxics Strategy, board and membership information, our water quantity report published with the Canadian Environmental Law Association (The Fate of the Great Lakes: Sustaining or Draining the Sweetwater Seas?), and the last two years of newsletter articles (and all future ones). We hope to have the site fully searchable by mid-summer 1998, so visitors need only type in a term to find out what GLU has published that contains that term.

# Staff profiles

# **Executive Director Margaret Wooster**

Margaret manages all aspects of Great Lakes United's work, including program activities, fundraising, financial management, and administration. She holds a masters degree in land use planning and a doctorate in English literature, both from the State University of New York at Buffalo. She is a member of the American Institute of Certified Planners. For the past ten years Margaret has worked as a consultant to local and regional governments and private landowners on water resource and habitat-protective policy development and site planning. She has served as president of the Friends of the Buffalo River and was a member of the Buffalo River Citizens Advisory Committee for three years.

# Field Coordinator Stéphane Gingras

Stéphane works out of Great Lakes United's Montréal office on issues related to toxic chemical pollution. Reg coordinates and produces all Great Lakes United publications, manages our computers and online activities, and staffs the Sustainable Waters Task Force. Shelley is organizing Great Lakes United's 1998 ten-city hearings on the Great Lakes Water Quality Agreement and Great Lakes – St. Lawrence River water pollution. Shelley also leads a number of projects for the Toronto Environmental Alliance.
