Executive Summary

Project title: Participation of Canadian organizations working on children's environmental health at *Children's Environmental Health II: A Global Forum for Action*

Organizations involved: *Alternatives Journal*, Campaign for Pesticide Reduction (CPR!), Canadian Association of Physicians for the Environment, Canadian Environmental Law Association, Canadian Institute for Environmental Law and Policy, City of Toronto Health Promotion and Environmental Protection Office, Learning Disabilities Association of Canada, Ontario College of Family Physicians Environmental Health Committee, Ontario Healthy Communities Coalition, Pollution Probe, Sierra Club of Canada, South Riverdale (Toronto) Community Health Centre, Toronto Environmental Alliance, Toxics Caucus of the Canadian Environmental Network, Women's Health and Environments Network

Geographic Location: Attendance of approximately 25 Canadians to international children's health conference in Washington D.C. September 8 - 11, 2001.

Background, Goals, Activities, Outcomes and Wider Impact: Building upon the foundation of information and analysis developed in the *Environmental Standard Setting and Children's Health* report, and by a range of other activities particularly relating to concerns about children and pesticides, work is proceeding towards a collaborative partnership of organizations working on children's environmental health in Canada. As the well-developed research base on these issues continues to grow, educational and outreach activities are occurring and in the planning stages. Central to this health and environmental partnership will be an internet-based educational collaboration for which other funds are being sought. The growing demand for public speakers and other educational tools is being partially met now by the participating organizations, by capacity-building exercises within planned "training trainers" workshops, and via a proposed film. For the purposes of this application, this educational partnership will be substantially enhanced through attendance at, and reporting of, the *Children's Environmental Health II: A Global Forum for Action* conference in Washington in September. This participation will enable continued building and strengthening of the capacity of Canadian environmental and health organizations to work together on these issues. Specific publishing outcomes will include a special issue of *Alternatives* journal and preparation of additional educational materials to be made available on-line as part of the broader internet-based partnership of Canadian organizations. Pending the ability to raise additional funding, an educational film is also planned. None of the organizations participating in this application would otherwise have the resources to attend this conference and several have submitted abstracts to present papers and/or run workshops. Their participation will add enormously to the depth of knowledge and capacity to continue educational work on children's environmental health issues in Canada.

Proposal

Participants: The Canadian Environmental Law Association (CELA) makes this application as part of CELA's Children's Health Project. Kathleen Cooper, Researcher with CELA, makes this application on behalf of CELA and the participating organizations. Ms. Cooper has been a researcher at CELA for 14 years. She was the principal researcher and writer, with a team of seven authors, in the preparation of *Environmental Standard Setting and Children's Health*, a 400 page study done at CELA in collaboration with the Ontario College of Family Physicians Environmental Health Committee. The study addresses the broad field of children's environmental health and includes a detailed analysis of the process underlying standard-setting in Canada with a focus on chemical and metal pollutants.

Organizations participating in this application and with a direct interest in and active programming on children's environmental health issues include:

Alternatives Journal, Campaign for Pesticide Reduction (CPR!), Canadian Association of Physicians for the Environment, Canadian Environmental Law Association, Canadian Institute for Environmental Law and Policy, City of Toronto Health Promotion and Environmental Protection Office, Learning Disabilities Association of Canada, Ontario College of Family Physicians Environmental Health Committee, Ontario Healthy Communities Coalition, Pollution Probe, Sierra Club of Canada, South Riverdale (Toronto) Community Health Centre, Toronto Environmental Alliance, Toxics Caucus of the Canadian Environmental Network, and the Women's Health and Environments Network. Within each of these organizations are individuals with specialized expertise in the field of children's environmental health.

Not included in the above list but certainly part of ongoing partnership building, is the Canadian Institute for Child Health (CICH). As co-sponsors of the conference, upon which this application is focused, CICH is not included although dialogue and coordination has occurred. Also not included as an organization but certainly as an interested individual is Jean-Dominique Levesque-René, a young cancer survivor and eloquent pesticide activist from Quebec. If this application is successful, he has expressed interest in participating in the conference as well and would be invited to be part of this effort.

Background: When CELA and the Ontario College of Family Physicians Environmental Health Committee (OCFP-EHC) undertook to research and report on whether or not the law was protective of children's environmental health in Canada, the work was approached as an exercise in setting down a uniquely Canadian foundation for further work. While much work has been done in the United States, the CELA-OCFP effort provided a Canadian perspective that had been lacking. Reaction and follow-up to the CELA-OCFP report has been very positive and the next Phase of this work has involved continued research and a variety of educational and outreach

activities. As well, numerous other reports and activities have occurred in Canada particularly within the organizations participating in this application. This activity has focused on child health concerns related to, for example, the use of pesticides, on the ongoing problems related to childhood asthma and other respiratory problems, and the unexpected and unregulated occurrence of lead in consumer products. The Laidlaw Foundation contribution to the CELA-OCFP effort very effectively built a necessary foundation for further work and CELA is in active discussions with the Laidlaw Foundation to assist again with a large and coordinated internet-based educational and outreach strategy. This strategy is based on a partnership model that will include most of the groups participating in this application.

The educational and outreach phase of the CELA-OCFP work has included far more requests for public speaking than either group has the capacity to accommodate. Capacity-building exercises are in preparation and CELA-OCFP is conducting a "training trainers" workshop in April in collaboration with the Women's Health and Environments Network (WHEN). A strong response was received from environmental and health professionals and activists wanting to participate in this workshop. Participants in such activities are already involved in children's environmental health issues and will act as multipliers with the help of the "training trainers" model. WHEN is also investigating funding sources for an educational film about children's environmental health. Ongoing discussions with *Alternatives* journal have resulted in the complimentary nature of the two proposals before NAFEC in this funding round. The principal authors of the *Environmental Standard Setting and Children's Health Report*, Kathleen Cooper and Dr. Loren Vanderlinden, have been asked by *Alternatives* to be guest editors for a special issue focused on children's environmental health issues. The coincident timing of the *Children's Environmental Health II: A Global Forum for Action* conference in Washington in September provides an ideal opportunity for deepening the understanding and involvement of Canadian organizations in these issues. The involvement of *Alternatives* will provide a forum for publishing the existing knowledge base in Canada and reporting on this international conference.

This application is seeking support for a key piece of the partnership, and capacity building therein, that we are creating among Canadian organizations focusing on children's environmental health issues. Although research will continue within our respective organizations, this partnership is primarily an educational one that will be substantially enhanced through attendance at, and reporting of, the conference in Washington. In summary, our collaborative educational work is still evolving but involves the coordination of four areas. These include: 1) direct person-to-person contact (public speaking, training trainers, etc.), 2) writing and publishing (for a range of publications including the *Alternatives* proposal), 3) the production of an educational film about children's environmental health, and 4) a comprehensive on-line collaboration that will maintain the autonomy of each organization while ensuring a coordinated one-window internet access point to all of our on-line resources.

Proposed Work and Outcomes: This project is seeking funding to be able to send approximately 25 Canadian representatives of primarily public interest environmental and/or health organizations, to the *Children's Environmental Health II: A Global Forum for Action* conference in Washington in September of this year. The budget has been prepared to enable this participation in as cost-effective as manner as possible. Initially, we investigated the option of chartering a bus, an option that seemed less expensive than airfare. However, this option is

cheaper only if most participants are travelling from a central location. Instead, the budget was prepared on the assumption that early bookings of airline flights will be as cost-effective as the bus option and enable participants to attend from more diverse locations across the country. Participants also require accommodation and conference registration costs covered.

Without funding support, it is unlikely that any of the organizations participating in this application would otherwise have the resources to attend this conference. Several participants have submitted abstracts to present papers and/or run workshops. The participation of all 25 Canadian representatives will add enormously to the depth of knowledge and capacity to continue educational work on children's environmental health issues in Canada. As noted above, this application is made in collaboration with an application from *Alternatives* journal since it is expected that several of the Canadian participants benefiting from this application will also participate in that effort. The special issue contemplated by *Alternatives* will be able to publish scholarly and summary contributions from Canadian authors as well as contributions from other conference participants who will be in attendance from all over the world. Participation in the conference will also contribute to the ongoing educational work described above within the growing Canadian children's health partnership.

Evaluation: The short term impact of this project will of course be the otherwise impossible opportunity for key players in Canadian organizations working on children's environmental health to be able to attend the *Children's Environmental Health II: A Global Forum for Action* conference in Washington in September of this year. Routine research and networking activities in recent months reveal that many of the most respected and knowledgeable players in children's environmental health in the United States and Mexico are planning to attend. Moreover, the conference planners have set a target of 50% participation from developing countries. Our Canadian participants will receive enormous benefit from being able to meet and learn from such an inspiring and diverse range of participants. In the longer term, the success of this Canadian participation will include the opportunity to augment Canadian efforts in children's environmental health research and educational efforts. This work will occur within and greatly add to our paper and on-line publishing plans as well as other educational and outreach activities. Additional longer-term impacts are noted below with respect to the wider impact that would occur if this proposal were successful.

Wider Impact/Relationship to NACEC program: The Canadian organizations participating in this application and in the broader partnership described, see the need for further research, policy analysis, educational and outreach activities on children's environmental health issues in Canada. Given the lead role taken by the United States on this issue in terms of research and policy responses, Canadian efforts need to both learn from these experiences and either avoid the pitfalls or ensure the appropriate application of policy responses in the Canadian political and legal context. One area of particular interest for Canadian participants in this conference will be the area of pesticide regulation. It is clear that the U.S. experience with the *Food Quality Protection Act (FQPA)*, a statute passed specifically to address growing concerns about children's health, has significant implications for Canada. The Canadian Pest Management Regulatory Agency states that it is following the lead of the U.S. in implementation of the *FQPA*. Moreover, the Canadian federal government appears poised to introduce long-awaited amendments to the Canadian *Pest Control Products Act* perhaps as soon as the fall, 2001 session.

It will be extremely beneficial to Canadian participants at the September conference to further their understanding of the U.S. experience with the *FQPA*, including strengthening and deepening contacts with colleagues in organizations from the U.S., Mexico and indeed from around the world. Similarly, contact with experts in the area of lead and children's health will be useful in ongoing work towards achieving adequate regulation to prohibit the increasingly dangerous practice of using lead in consumer products. This problem has international trade dimensions that require a response grounded in international collaboration. The contacts and networking that will be possible at this conference will enable and further such collaboration.

Budget: The following budget is presented on the assumption that it will cover the travel, accommodation and conference registration costs for up to 25 individuals to attend the conference in September. If costs, including US-Cdn exchange rates, are higher than budgeted, the number of participants will be reduced to 20.

Other funding sources: At this time, there are no other funding applications being made to other sources to pay for this particular proposal. However, the broader research, education and outreach strategy is the subject of a comprehensive fundraising effort to advance the emerging partnership of Canadian organizations working on children's environmental health. One immediate component of that strategy is the complementary application from *Alternatives* journal before NAFEC in this funding round.

Building upon the Children's Health Project, Phase 1 (\$60,000) and Phase 2 (\$40,000) already obtained from the Laidlaw Foundation, CELA is in active negotiations with the Laidlaw Foundation to assist with the next phase of this work. Involved in this strategy are several of the groups named in this application. Funds in the range of \$70,000 to \$100,000 are being sought to pay for specific research activities as well as the work involved in developing several additional funding applications to major funding bodies and foundations (including but not limited to the Joyce Foundation and the Trillium Foundation).

In parallel and complementary to our dialogue with the Laidlaw Foundation, CELA and the Canadian Association of Physicians for the Environment are preparing a detailed funding application to the Community Learning Networks (CLN) program of Human Resources Development Canada. The CLN program is geared to innovative on-line learning partnerships. To complement the CLN proposal, another application is in preparation for the fall to be submitted to the Voluntary Action On-line Program of the Ontario government. This program assists with the technology associated with providing on-line resources and opportunities for public involvement in issues of concern. Both of these funding sources provide multi-year funding.

Resume of Organization and Applicant

Organization

The Canadian Environmental Law Association (CELA) is a non-profit, public interest organization founded in 1970. Funded substantially by Legal Aid Ontario, CELA is an environmental law clinic dedicated to providing legal services to low income people and disadvantaged communities, and advancing the cause of strong environmental protection through advocacy, education and law reform. In addition to providing direct legal representation and summary advice, CELA's law reform and public educational mandates include advocacy on ensuring access to environmental justice and protecting citizens environmental rights. This work occurs at the provincial, national and international level. Three strategic campaign areas have been chosen via organizational strategic planning and, although part of the Legal Aid Ontario mandate, these areas are enhanced through funding from additional sources of revenue. CELA's strategic campaigns include the areas of Environment and Health, Water, and Globalization and the Environment.

Within the area of Environment and Health, CELA's Children's Health Project is entering a third year of productive collaboration with physicians and other environment-focused health organizations. The Children's Health Project initial collaboration with the Ontario College of Family Physicians Environmental Health Committee is expanding to include a wide range of organizations working on environment and health issues related to children.

Applicant

Kathleen Cooper graduated from the University of Toronto in 1984 with a specialist degree in Environmental Studies. She has worked in environmental research positions for various public interest organizations and is co-author of several publications about environmental lead pollution including *The Citizens Guide to Lead: Uncovering a Hidden Health Hazard*, NC Press, 1986. She joined the Canadian Environmental Law Association as a researcher in 1987. Research, writing, advocacy and community organizing responsibilities at CELA included getting lead out of Canadian gasoline as well as coverage of issues such as environmental assessment, toxic substances, food irradiation, pesticides, climate change, land use planning and in recent years, environmental deregulation and natural resource privatization in Ontario. She is principal author of a large research project published in May of 2000 addressing environmental standard-setting and children's health. This joint effort of the Canadian Environmental Law Association and the Ontario College of Family Physicians Environmental Health Committee is continuing with various educational and outreach activities and further research into reforming federal pesticides legislation.

APPLICATION FOR INCORPORATION OF A CORPORATION WITHOUT
SHARE CAPITAL UNDER PART II OF THE CANADA CORPORATIONS ACT

To the Minister of Consumer and Corporate Affairs of Canada

I

The undersigned hereby apply to the Minister of Consumer and Corporate Affairs for the grant of a charter by letters patent under the provisions of Part II of the Canada Corporations Act constituting the undersigned, and such others as may become members of the Corporation thereby created, a body corporate and politic under the name of CANADIAN ENVIRONMENTAL LAW ASSOCIATION/L'ASSOCIATION CANADIENNE DU DROIT DE L'ENVIRONNEMENT.

The undersigned have satisfied themselves and are assured that the proposed name under which incorporation is sought is not the same or similar to the name under which any other company, society, association or firm, in existence is carrying on business in Canada or is incorporated under the laws of Canada or any province thereof or so nearly resembles the same as to be calculated to deceive except that of Canadian Environmental Law Research Foundation which has signified its consent to the use of the said name and that it is not a name which is otherwise on public grounds objectionable.

II

The applicants are individuals of the full age of twenty-one years with power under law to contract. The name, the place of residence and the calling of

each of the applicants are as follows:

The said Douglas G. Edward, Philip Sanford and Robert Timberg will be the first directors of the Corporation.

III

The objects of the Corporation are:

(a) to use and promote the use of the legal system to defend the environment, through

- (i) advocacy before Courts and administrative tribunals;
- (ii) law reform;
- (iii) community education; and
- (iv) such other means as the Board of Directors may determine; and

(b) advocate means for all citizens to participate in

the making of decisions which affect the environment.

(c) obtain for citizens by means of an Environmental Bill of Rights, or other methods, the right

- (i) to a healthy and attractive environment;
- (ii) to defend the environment in the courts;
- (iii) to require sound environmental impact statements before development decisions;
- (iv) to information concerning the environmental consequences of government or private projects;
- (v) to participate in the setting of standards of quality for the environment;
- (vi) to require recreation areas, such as parks, to be held in public trust, and allow citizens to protect the parks through the courts, and
- (vii) to allow class actions so that one person could sue on behalf of all others who also suffer from environmental destruction.

IV

The operations of the Corporation may be carried on throughout Canada and elsewhere.

V

The place within Canada where the head office of the Corporation is to be situated is:

The City of Toronto in the Municipality of Metropolitan Toronto.

VI

It is specially provided that in the event of dissolution or winding-up of the Corporation all its remaining assets after payment of its liabilities shall be distributed to one or more recognized charitable organizations in Canada.

VII

In accordance with Section 65 of the Canada Corporations Act, it is provided that, when authorized by by-law, duly passed by the directors and sanctioned by at least two-thirds of the votes cast at a special general meeting of the members duly called for considering the by-law, the directors of the Corporation may from time to time

- (a) borrow money upon the credit of the Corporation;
- (b) limit or increase the amount to be borrowed;
- (c) issue debentures or other securities of the Corporation;
- (d) pledge or sell such debentures or other securities for such sums and at such prices as may be deemed expedient; and,
- (e) secure any such debentures, or other securities, or any other present or future borrowing or liability of the Corporation, by mortgage, hypothec, charge or pledge of all or any currently owned or subsequently acquired real and personal, moveable and immovable, property of the Corporation, and the undertaking and rights of the Corporation.

Any such by-law may provide for the delegation of such powers by the directors to such officers or directors of the Corporation to such extent and in such manner as may be set out in the by-law.

Nothing herein limits or restricts the borrowing of money by the Corporation on promissory notes made, drawn, accepted or endorsed by or on behalf of the Corporation.

VIII

The by-laws of the Corporation shall be those filed with the application for letters patent until repealed, amended, altered or added to.

IX

The Corporation is to carry on its operations without pecuniary gain to its members and any profits or other accretions to the Corporation are to be used in promoting its objects.
