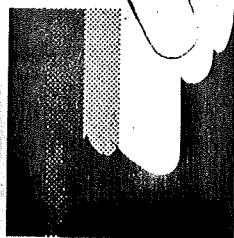

Re: Brampton Official Plan Request for Referrals

Attached is the letter which we have today sent to the Minister with respect to the withdrawal of our request for referral of part of Table 1 of the Official Plan.

After discussing Table 1 with John Marshall and with Doug Billett, we decided that the Region's request that Area 7 be withdrawn in order to allow approval of the Region's small sub-division would be acceptable to us. It was our information however that no immediate approvals or building will be pursued with respect to Area 6, and that there is therefore no reason to withdraw our request for referral with respect to that column of Table 1. It also appears that the densities proposed for Area 6 may be of concern to our client group.

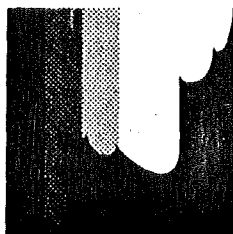

Re: Brampton Official Plan Request for Referrals

On October 13, 1983, we requested referral, on behalf of the Association of Peel People Evaluating Agricultural Land, of several policies, designations, and tables. In response to our request, you made referrals to the Ontario Municipal Board on January 4, 1984.

We have recently been requested, by the Region of Peel, to re-evaluate our request that all of the columns in Table 1 on page 52 of the Official Plan be referred to the Board. After reviewing this request, my client has decided that the column specifically relating to Area 7 of Table 1 may be taken back from the Board. We are therefore requesting that the column of Table 1 respecting Area 7 be taken back from the Board pursuant to your authority under section 52 of the Planning Act, R.S.O. 1980.
