At 11:45 a.m., or as soon thereafter as possible, onWednesday, May 10, 1989, in Committee Room No. 4, second floor, City Hall, the Land Use Committee will consider recommending to City Council the enactment of a by-law designating certain lands in the vicinity of the North Shore, the Outer Harbour and the Outer Harbour Headland (shown on the plan attached), as an Area of Site Plan Control pursuant to Section 40 of the Planning Act.

In such areas, Council may require that plans and drawings be submitted and approved as a condition of certain types of development. In addition, the City may require site landscaping, off-street parking and loading facilities, land for street widenings if appropriate, and an agreement, registered on title, to secure these requirements. However, small projects which have little effect on their surroundings are exempt from City review under these provisions.

Information regarding the proposed designation may be obtained by telephoning Peter Langdon, the planner in charge, at 392-7611. A copy of the report of the Commissioner of Planning and Development may be obtained from the City Clerk's Department by telephoning 392-7033.

Interested persons, groups and organizations are invited to attend this meeting and present their views respecting the proposed designation, and should notify the City Clerk's Department at 392-7033 by 12:00 noon on Tueaday, May 9, 1979, if they wish to make representations respecting this matter.




Your Committee at its meeting of October 5, 1988 adopted the Report (September 23, 1988) from the Commissioner of Planning and Development. The recommendation contained in the Report requested the City Solicitor submit a draft by-law to extend the area of site plan control in the vicinity of the North Shore, the Outer Harbour and the Outer Harbour Headland as zoned by By-law No. 528-88. Enclosed is the draft by-law designating the subject lands as an area of site plan control.

Recommendations:

That the City Clerk give notice to the owners of the lands affected by the draft by-law and a public hearing be held by the Committee and that the owners of the lands affected be given an opportunity to speak to the matter. If following a public hearing the Committee wishes to approve the draft bylaw, it could recommend:

NO. A BY-LAW

To designate a certain area in the vicinity of the North Shore, the Outer Harbour and the Outer Harbour Headland as an area of site plan control.

Whereas Council, at its meeting held on the day of , 1989 adopted Clause of Land Use Committee Report No. ;

And Whereas the City of Toronto is described as a proposed site plan control area in the Official Plan in effect in the City of Toronto;

And Whereas Section 40 of the Planning Act permits the Council of a municipality, by by-law, to designate the whole or any part of the area so described by the Official Plan as a site plan control area;

Therefore the Council of The Corporation of the City of Toronto enacts as follows:

1. Map Nos. 51F-524, 51F-525, 51F-526, 52F, 52G-512, 52G-513, 53G-511 and 53G-512 contained in Appendix "A" annexed to By-law No. 239-86, being "A By-law to designate certain lands in the City of Toronto as areas of site plan control", as amended, is further amended by designating the lands shown thereon and outlined by heavy lines on the map attached hereto and forming part of this by-law as an area of site plan control.
