SUNDAY, JUNE 4 – VIEWING DAY AT THE SPIT

Again this year, we are celebrating World Environment Day by inviting the public to come and explore the Spit, enjoy the quiet, carfree experience, and get acquainted with its wildlife.

For the second consecutive year, we have received a grant from Environment Canada to hold a "Viewing Day" at the Spit. Our objective is to increase the awareness of this unique urban environmental resource among the public.

Last year, the event was a great success. It attracted several hundreds of first-time visitors. We had viewing stations, staffed by naturalists, and a brochure with information about the wildlife areas that enabled people to take a self-guided tour of the Spit.

We are planning a similar event this year, on Sunday, June 4, from 10:00 a.m. to 4:00 p.m. Come and join us in this celebration of World Environment Day. Come to learn more about the Spit. Come to enjoy the Spit ...and bring your friends.

Can you help? No experience necessary!

Put up posters — Can you put up posters in your neighbourhood – in stores, workplaces, schools, churches, shopping malls, community centres, on construction hoardings, etc. Call 699-6442 and we will send you a supply of posters.

THC MARINA: WHOSE SIDE IS THE CITY ON?

The Toronto Harbour Commission has been alowed by the City to merrily dump lakefill to construct its huge 1,200 boats marina in the Outer Harbour by the neck of the Spit, despite a "natural resource area" zoning designation applied last year to the waterlot by City Council.

This zoning designation (Gr) permits only conservation lands and bathing stations and prohibits lakefilling. But the THC has been dumping fill, up to 1,800 truckloads a day diverted from the completion of the Spit, to build its marina and has started building the facilities for the first 400 boats, all without having applied for the zoning changes.

Earlier this year, the THC requested the City to provide service connections (sewers, etc.) to the marina. The City Planning Department in a report to the Land Use Committee recommended that **no connections be provided to the marina**.

Naturalists and small boat sailors in agreement

The issue was discussed at Land Use Committee on March 29. Friends of the Spit, naturalist groups and the north shore sailing and sailboarding clubs spoke overwhelmingly in favour of the Planning Department report and against the THC marina. (The only one praising the marina was the paid lobbyist for the Ontario Sailing Association!).

Speaker after speaker got up and said that the marina was ill-conceived, would ruin the public's enjoyment of the area and generate large boat traffic that is incompatible with the pursuit, enjoyment and safety of waterfront public recreation.

A very poor show

Given this massive opposition to the marina from the public, one would have thought that at least the Committee would discuss planning issues, particularly since it was the first time the THC marina came under scrutiny by the City (despite repeated requests for scrutiny by Friends of the Spit and other groups).

Most of the discussion centered around the fact that the "poor" owners of luxury boats to whom berths had been pre-sold (on an unzoned site) were going to be upset and, of course, deprived of their constitutional rights. How's that for the tear-jerker of the year. If you have followed the Harbourfront saga, this will sound very familiar to you. Plus ça change...

Zoning proposal to be considered on May 10

The proposal to rezone the THC marina from Gr to Gm will be considered at Land Use Committee on Wednesday, May 10, at 11:00 a.m., in Committee Room 4, New City Hall. We will be speaking at that meeting. Please make an effort to come and speak as well to request the City not to allow the THC marina to be rezoned.

Membership lists


Friends of the Spit does not exchange or sell any of its membership lists. This has always been our policy. All membership information is kept confidential and used for file purposes only.
