Over the past several weeks, Ontarians have expressed their concerns about the two agreements collectively known as Annex 2001. The Council of Great Lakes Governors and the Premiers of Quebec and Ontario released these agreements for public review on July 19, 2004 for a ninety-day review period ending October 18th. It is our hope that the Ontario government will extend the comment period to allow more people to respond to these important drafts. To assist people with their responses, the Canadian Environmental Law Association is proposing to hold a workshop to further review and discuss these two agreements. CELA believes that a strong public response has the potential to improve the regimes being proposed and that it is important to spend the time now to protect the Great Lakes in the long-term.
